Motion to approve passed: minutes approved as submitted

TREASURERS REPORT

Checking: \$44,398.55 Savings: \$25,027.38 \$69,425.93 16 bricks were sold during the 2016-17 term, netting \$4000. Money for CERT will be discussed at a future meeting.

OLD BUSINESS

- 1. **Easter Egg Hunt**: The flyer has been circulated. A motion was made and passed that expenses be approved equal to or less than last year's expenses of \$1200.
- 2. **Bike Racks**: No report, but Jeff plans to speak to Diane Dixon regarding their placement some time during the coming year.
- 3. **Bay Beach Cushions**: A motion was made and passed that \$3000 be allotted for new cushions to be ordered. Dennis Borowsky will implement.
- 4. **CERT**: It was discussed whether CERT falls under the purview of the Foundation or BPPA considering the two groups' filing status. Per Ken Drellishak, no matter who is ultimately responsible for CERT, the city sees BPPA as the spokesperson for the group. To-date, the Foundation has supplied the 2-way radios and defibrillator. CERT also received funding from the sale of emergency kits and commemorative bricks.

NEW BUSINESS

- 1. **BPPA Letter of Support for the Junior Lifeguard Facility**: Mark reported that the letter has been sent and a letter of appreciation received from the program director.
- 2. **Summer Security Patrol**: Terry reported that KMA Security and Patrol has been contracted to fulfill our security needs.

Schedule: Beginning May 27-July 3 8PM-4AM Wednesday – Sunday

July 4-September 4---7 days/week 8PM-4AM

The officer will be invited to our next meeting for introductions to the Board and to the first summer social for introductions to the community. The company will provide daily "incident reports" to Terry. The new company and its schedule will be mentioned in the upcoming Pointer.

- 3. **Bay Beach**: Mark reported that Max Johnson has confirmed that the propane tanks are full and we should have enough to last the summer due to the extra tanks we've acquired. Jeff reported that he has a call in to a painter and expects the bid to land near \$1000. This should be confirmed at the next meeting. It was moved and seconded that these funds be approved for the painting.
- 4. **Pointer**: Mark has nearly completed the next edition of the Pointer, but could use a few short stories. Mention will be made of the upcoming Membership drive with a possible registration form to be included in the next issue, and the schedule for the next CERT drill on 4/29 will be included.
- 5. **Membership**: Angela Caliger reported that the next membership drive will kick-off on June 9, with a "last chance to dance" date of 7/4 so that directories can be distributed in August. The new registration forms will specify that dues cover 7/1-6/30 to clarify the term. Angela will have discretion with regard to dues received recently, whether because an applicant is a new resident or a late-paying member.

Current membership hit 440 at the end of the 2016-17 term, and the goal is to reach 500 2017-18.

- 6. **CERT**: The April 5 block captain meeting was attended by roughly 50% of the peninsula captains. The annual block captain drill is scheduled for 4/29, 9am, at the L Street park.
 - a. Supply Chest: An encroachment permit is required for the CERT supply chest to be placed under the bench at the Tot Park. It is in the works.

- 7. **Commemorative Bricks**: 16 bricks were sold in the 2016-17 fiscal year. An agenda item will be added for next month's meeting to discuss how funds will be shared with CERT.
- 8. **Sober Living Home**: No license has been issued yet.
- 9. **Hospitality**: New hospitality chair, Jule Gainey, provided a calendar of upcoming events as follows:
