- BVAC REPORT: Gloria reported the remodeling of the Balboa Village including the Fun Zone and boardwalk, Balboa Inn and ExlporOcean/Newport Harbor Nautical is moving along. As part of the remodel this summer a carousel, bumper cars, and touch tanks for ocean education should be placed in the Fun Zone area. Gloria also stated that the theater space is able to move ahead with the passing of its remodeling plans by the Costal Commission.
